**Adult Driver Education Provisions**

1. Each student will receive private, one-on-one instruction from a licensed instructor.
2. Lakeshore Precision Drivers Training will conduct behind the wheel instruction in a dual-controlled automobile, fully insured, covering each participant enrolled in the program.
3. Driving Tasks to be achieved include:
 

*Driver skill level assessment      Road Skills Test Preparation      Vehicle Operation*

*As needed, instruction/reinforcement in:*

*Residential/City/Rural/Freeway Driving      Backing      Parking*
4. At the conclusion of each driving lesson your instructor will review the student's progress and provide input as to whether additional instruction is necessary.
5. Should a student miss a class session or driving session without 24 hrs. notice, a fee of \$45.00 will be assessed to make-up the lesson. Make-up is the student's responsibility and will need to be coordinated with the instructor.
6. Depending on the students level of driving proficiency, the student may choose the following packages
  - a. **Skill assessment: \$45 (Approximately 1 hr.)**
    - i. Each Student will receive an assessment to help determine their skill level. This will help the student and instructor determine the appropriate level of training is needed. (This will be deducted from the \$90.00 deposit).
  - b. **Plan A: One or Two Lesson preparation for Road Skills Test**
    - i. 1 – two hour block: **\$90**
    - ii. 1 – one hour block: **\$45**
  - c. **Plan B: Some Driving Experience: \$135.00**
    - i. 3 – one hour blocks
  - d. **Plan C: Little/No Driving Experience: \$270.00**
    - i. 6 – one hour blocks
    - ii. Combination of 6 total hours of classroom instruction and driving
  - e. **Customized plans available depending on individual needs of the student can be calculated at a rate of \$45.00/hr. Plan details will be determined at the time the contract is signed.**
  - f. **Full payment is required after the evaluation drive and before any instruction will begin.**

### TERMS

The undersigned understands and agrees to participate in the program on the basis that they meet the physical requirements specified by the law for issuance of a motor vehicle operator's license. For a student to take part in Adult driver education program, verification must be received that the student has obtained a **CURRENT AND VALID** Michigan Temporary Instructional Permit (TIP) from the Michigan Secretary of State's Office. The Temporary Instructional Permit (TIP) **MUST** be with the student each and every time they drive. Failure to have the permit with them will forfeit their drive session and the make-up session fee will be assessed. Should you miss a session due to illness, it will be the student's responsibility to schedule a make-up session through the business office. Package selection and payment must be made prior to any driving taking place.

**The following items must be returned to Lakeshore Precision Drivers Training, LLC at least one week prior to the start of a driving session:**

- 1) **Non-Refundable deposit of \$50.00 (Checks made payable to LPDT)**
- 2) **Signed copy of the contract**
- 3) **A photocopy of the student's valid Michigan Temporary Instructional Permit (TIP)**

*There will be a \$25.00 fee for all returned checks.*

### REFUND POLICY

If for any reason you decide to withdraw from the course before completion, your refund will be based on the following pro-rated schedule:

1. If withdrawal is made before any driving sessions begin, all monies less the \$50.00 deposit will be returned.
2. If withdrawal is made after ANY DRIVING has taken place, no refund will be given.
